Pilots operating from the Air Sailing Gliderport are required to satisfy the following requirements prior to their first flight of the year:

Be accredited for an annual Safety Briefing Read the current "<u>Airport Operations in the COVID-19 Environment Information</u>" Read the "<u>Operating Procedures Manual</u>" Sign the "<u>Operating Procedures Manual Certification</u>" Sign an annual <u>Waiver of Liability</u> Provide <u>proof of acceptable aircraft insurance</u>.

There are several options available by which to satisfy these requirements:

# Safety Briefings

Attend the live <u>Safety Briefing Webinar</u>, Watch the recording of the Safety Briefing Webinar, or Receive a <u>personal Safety Briefing</u>

To Certify You've Received a Safety Briefing:

For the live Safety Briefing Webinar:

- 1) Indicate you attended a live safety briefing webinar on your OPM Certification
- 2) Return your document (as below)

For a recorded safety briefing (available a few days after the live webinar):

- 1) Register for and watch the recorded Safety Briefing Webinar
- 2) While watching, take careful note of each poll's phonetic alphabet designation
- 3) Include each poll's designation on your <u>OPM Certification</u>
- 4) Return your document (as below)

For a personal safety briefing:

- 1) Indicate the date and by whom given on your OPM Certification
- 2) Return your document (as below)

- 1) Complete and sign your <u>OPM Certification</u>
- 2) Return your document (as below)

### Waiver

The <u>Waiver</u> is published on the website.

- 1) Complete and sign your <u>waiver</u>
- 2) Return your document (as below)

### **Provide Proof of Acceptable Aircraft Insurance**

Return your proof of acceptable aircraft insurance document (as below).
